Current User Testing Status

- The vast percentage of participants are connected and testing
- Almost half of the participants are sending steady volumes to the system
- High volumes have also been observed from some participants
- Almost one sixth of participants have already completed the mandatory test cases
- The testing of core functionalities is almost completed
- There has been an increase in the pace of closure of defects over the last month

Ancillary System Testing Campaign

Ancillary System Testing

- The Ancillary System Procedures run daily in the test environment and can be tested in a standalone manner at any stage
- The campaign allows the Ancillary Systems and their settlement banks to test together in a co-ordinated way and also simulates production
- The testing period runs for 3 weeks with the possibility of further co-ordinated testing in September
- The Eurosystem has created a dedicated document which has been shared with the NCBs and Ancillary systems
