Performing tasks in the public interest requires adequate data processing of mail – in other words, scanning images of the exterior of business mail, and capturing images of the contents of the mail itself – in

order to facilitate efficient and punctual communication between the ECB, national central banks, national competent authorities, business counterparts and the public. By scanning and digitally distributing mail, we ensure secure and prompt delivery of communications, thereby supporting smooth business operations and timely decision-making.
