- (1) The meeting is expected to continue in the afternoon until approximately 4 p.m.
- (2) The draft minutes will be circulated shortly.
- (3) The Foreign Exchange Policy Sub-Committee examined "Issues raised by the Commission's suggestions for an exchange rate arrangement between the Community and third countries" (Report No. 1 of 14th September 1990 - FXP/90/01). However, given the extensive agenda, the Committee may consider postponing the discussions under this heading to the December meeting and limit itself at the present meeting to establishing a mandate for the Foreign Exchange Policy Sub-Committee regarding bilateral swap arrangements between the Norwegian Central Bank and individual EEC Central Banks.
- (4) Draft mandates (together with a brief note on the establishment of the Committee on Financial Matters) will be circulated shortly.
- (5) A revised version of the draft Statute which has been prepared by the Committee of Alternates with the assistance of the Sub-Committees and the ad hoc group of legal experts was circulated by the Secretariat on 25th October 1990. A draft Introductory Report together with a Commentary and a list of suggested Treaty provisions was circulated on 2nd November 1990.
- (6) These documents (charts, "concertation tables" and Monthly Statistical Series) will be prepared by the Secretariat and will be ready for the Governors in Basle.
- (7) The draft Report prepared by the Secretariat and reviewed by the Concertation Group will be circulated to the Governors in Basle.
- (8) The ex ante exercise, which will be held in accordance with the procedure adopted by the Committee in July 1990, will be based on Report No. 1 from the Monetary Policy Sub-Committee ("Monetary Policy Intentions for 1991") which was circulated on 2nd November 1990. Furthermore, there will be an oral statement by Monsieur Rey, summarising the discussion in the Committee of Alternates on the Report by the Monetary Policy Sub-Committee and on the conceptual issues as described in the Secretariat's note dated 18th September 1990, "Assessing the mutual compatibility of national monetary policies".
