- (3) The monitoring will be prepared by the Foreign Exchange Policy Sub-Committee Group (Monitoring Group) and the Committee of Alternates and will be based on the "Monitoring Charts", "Effective Exchange Rate Charts", "Concertation Tables" and "Monthly Statistical Series" which will be drawn up by the Secretariat and will be ready for the Governors in Basle.
- (4) The draft report prepared by the Secretariat and finalised by the Concertation Group will be circulated to the Governors in Basle.

- (5) The ex ante exercise will be based on Report No. 6 from the Monetary Policy Sub-Committee ("Monetary Policy Intentions for 1992") which will be circulated shortly.
- (6) Follow-up to the recent IGC meetings (see, in particular, the Secretariat's summary notes on the meetings of 1st, 7th to 8th and 22nd October 1991; a summary note of the meeting on 4th to 5th November 1991 will follow shortly) and, in particular, a discussion of the Governors' opinion on the relevant Articles of the draft Treaty and Statutes presented by the Presidency on 28th October 1991.
- (7) An oral statement will be made on behalf of the Committee on financial matters at the meeting.
