The Committee may also wish to take into account the note on "Recent ERM tensions: Main developments and preliminary assessments" prepared by the Economic Unit and circulated to the Committee members on 15th October 1992.
- (4) The draft report prepared by the Secretariat and finalised by the Concertation Group will be circulated to the Governors in Basle.
