#### Reason for change and expected benefits/business motivation:

The T2S Penalty Mechanism's (introduced with CR-654) provides the daily calculation and reporting of cash penalties for settlement fails, a monthly reporting of the aggregated amounts of cash penalties computed for a given month as well as the operational tools which are necessary for T2S Actors.

Non Functional Tests revealed that the time required to process penalty reference data (daily prices), in T2S, exceeds the timeframe for their provision according to the latest information. Therefore, CR-654 detail assessment assumptions cannot be met.

The processing of daily prices will finish after the currently foreseen 8:30 a.m., hence delaying the subsequent calculation, recalculation and reporting of penalties.

As a consequence, it was agreed by the OMG to raise this change request to fine tune the schedule of activities as proposed by the 4CB, which allows meeting the business and operational needs, but avoids to purchase additional processing power and, consequently, its additional costs.

The description of the updates and optimizations of the schedule of activities is provided below.

#### Description of requested change:

The following updates and optimizations in the schedule of activities are proposed:

- To postpone 75 minutes, the expected completion time for the processing of reference data:
  - Processing and preparation of reference data submitted before the deadline: To be completed by 9:45 (now 8:30)
- To postpone, accordingly, the start and expected completion times of the following activities due to the new completion time of the processing of reference data:
  - New start of the Calculation of penalties expected at 9:45 (now 8:30)
  - Note that 9:45 is the latest time by when the Calculation process is expected to start, but the related event will be scheduled at 9:15 so it starts as soon as possible (as soon as previous processes have finished)
  - New time for expected completion of the Recalculation (plus End of appeal period process on the 13<sup>th</sup> business day of the month), that triggers the restart of the screens to query and modify penalties: At the latest at 12:15, normally, at 12:25 on the 13<sup>th</sup> (now 11:00)
  - Completion of the daily reporting:



- Daily penalty list report: To be completed by 12:25 (now 11:30<sup>5</sup>)
- List of modified penalties report: To be completed by 12:45 (now 12:00)
- To offset the impact on the penalty related screens availability (due to the later completion of recalculation and End of appeal period processes, after which related screens become available again) it is proposed:
  - To separate the deadline for provision of reference data, from the deadline for provision of penalty modification requests and stop screens to query and modify penalties (currently same deadline) and set it at a later point in time. I.e.:
    - New ad-hoc deadline for provision of A2A penalty modification requests and stop screens to query and modify penalties: 9:00 (now 7:30)
  - To no longer stop the screen "Monthly Net Penalty Amounts Search/List" during the daily
    processing of penalties (because there is no need to stop it, as this screen can be available during
    these processes).
- To perform the monthly reporting at an earlier time (in parallel with reference data processing), hence avoiding the delay of the monthly reporting because of the abovementioned updates:
  - Monthly aggregated amounts report:
  - To start at 8:30 (now at 12:00) and to be completed by 9:30 (now 12:45)






#### **DIAGRAM 1 - REAL-TIME SETTLEMENT SCHEDULE**




#### **DIAGRAM 2 - REAL-TIME SETTLEMENT SCHEDULE**





Changes of the schedule as described above.

A new event "PMSS - Penalty Mechanism- Stop Screens and penalty modification requests" is created in order to separate the Penalty Mechanism Deadline for provision of data (signalled by event "PMDD") from the deadline to provide Penalty Modification Requests. This will improve the availability of penalty related screens, currently unavailable between events "PMDD" and "PMRR", which, after the change, will be unavailable between "PMSS" and "PMRR".

To further improve the availability of screens, the "Monthly Net Penalty Amounts - Search/List" screen will be available during the daily processing of penalties as there is not needed to stop it during this processes.

A new event "SVDF - Penalty Mechanism- Save Delta Files" is created in order to allow the definition of the contingency processes requested to skip the Recalculation in case of need and to recover it at a following business day. It will also trigger in LCMM the storage of the Delta Files.

### Penalty Mechanism

- Update the Penalty Mechanism documentation according to the new schedule of activities
- Use new event "PMSS Penalty Mechanism- Stop Screens and penalty modification requests" to start queueing A2A Penalty Modification Requests (instead of "PMDD").
- Update the relevant penalty screens to define the new event "PMSS Penalty Mechanism- Stop Screens and penalty modification requests" to make them not available (instead of "PMDD").
- To further improve the availability, screens "Monthly Net Penalty Amounts Search/List" will no longer be stopped and will be available during the processing of penalties

Event for A2A penalty modification requests and stop screens to query and modify penalties needs to be updated from PMDD into PMSS. Blocking of Monthly Net Penalty Amounts - Search/List should be removed.
