



TARGET2 SSP RELEASE 12.1: TESTING ACTIVITIES

On 22 January 2018, the Eurosystem informed the TARGET2 community about the introduction of the new ISO 20022 version 2017 compliance messages with the document "[Final content of the SSP release 12.0](#)" for which the first deployment occurred already on 20 November 2018 with the release 12.0, and the second deployment is planned for the 11 June 2019 with the release 12.1¹.

In relation to the testing activities of release 12.1, three further deliveries were published on the TARGET2 Website, with "[Dates for testing and go-live for SSP 12.1](#)" on 16 October 2018, with "[Testing and TARGET12.1-Introduction of new ISO 20022 version for T2S related messages](#)" on 11 December 2018, and with the [Interoperability testing document release 12.1](#) on 10 January 2019.

The Eurosystem would like to specify the test cases applicable for the release 12.1, as well as a bug fix list, that could be revised and re-published shortly before the testing activities starts on the 11 March 2019.
